Sub: Request for issuing uniform guidelines in fixation of Pay – reg.

We have been receiving a number of representations from various members of our Association seeking redressal for their grievance in the pay fixation option after II PRC. The request of the TTAs who have been promoted after 1-1-2007 and exercised option to fix the pay after their promotion to the cadre of JTOs had not been considered by some of the SSAs. It is pertinent to mention here that all the circles viz. AP, STR Chennai Telephones etc have allowed all the officials who were promoted to the cadre of JTO after 1-1-2007 to fix their pay from the date of their promotion. There is provision in the II PRC for fixation of pay either from 1-1-2007 or from the date of promotion/next increment. But the above privilege is not extended to the executives who have been promoted to the cadre of JTO after 1-1-2007 in some SSAs of TN Circle. For your kind reference a pay fixation memo issued by AP Circle in respect of Shri.T.V.Krishna Reddy,TTA who was promoted to the cadre of JTO after 1-1-2007 and Pay slip of Shri.R.Moorthy STR are enclosed herewith. Kindly find herewith a representation received from Shri. G.Saravanakumar JTO IMPCS Trichy as a sample case. He was denied for option for the revision of pay from the date of the promotion after 1-1-2007. He is ready to forego the arrears from 1-1-2007 to the date of promotion to the cadre of JTO. There are similar cases throughout Tamil Nadu. Hence it is requested to kindly issue uniform guidelines to the field units to allow such cases to fix their pay from the date of promotion instead of 1-1-2007.
