
Sub: Pay anomaly in the cadre of AGM (Adhoc)- Case of Shri. V.Muthusamy AGM/MA

After the latest SDE to DE (Adhoc) promotion orders issued recently, this Association is receiving lot of representations from our senior members regarding pay anomaly. It has been brought to our notice that senior officers of STS cadre who are regular are drawing less pay than the officers who were promoted recently on adhoc basis. There is huge difference in the pay between 1973 and 1975 onwards recruits. A representation received from Shri. V.Muthusamy AGM/MA and Shri. C.Kadirvelu AGM/MA who are 1973 recruits and were appointed on regular STS cadre, is enclosed herewith for your kind perusal. The above officers request for stepping up of pay on par with their junior Shri.C.Kalyanasundaram was turned down by the DGM Finance of Madurai SSA. Hence we request you to kindly intervene on this issue and settle the case at an early date.

2. Kindly recall our earlier meeting with you and reminder thereon over the pay anomaly issue of Shri.S.Radhakrishnan SDE/TVL and Shri.C.Govindasamy DE/ERD. We are pained to bring to your kind notice again regarding non settlement of pay anomaly case of Shri.S.Radhakrishnan SDE/TVL and Shri.C.Govindasamy DE/ERD even after several years. We came to know that comparative statement from TVL has been called for, keeping the service book of Shri.S.Radhakrishnan at head quarters itself. Second comparative statement has been called for in the case of Shri.C.Govindasamy DE/ERD. This causes mental agony to our members. Hence we request you once again to kindly intervene over this issue and settle the case early.
